Purpose: To review the progress of the Detroit River International Crossing Project.

Introductions/Agenda

Mohammed Alghurabi asked those in attendance to introduce themselves.

Meeting Conduct Procedures same.

Mohammed Alghurabi reviewed the agenda. He then introduced Terrance Hicks and noted

Terrance would discuss the MDOT Disadvantaged Business Enterprise (DBE) Program and the

prequalification process for firms wanting to work on DRIC project.

Mohammed noted that the real estate video was on the MDOT web site. It explains the

acquisition and relocation process.

He mentioned the next two LAC/LAG meetings will be at the Doubletree Hotel at Ford Road

and the Southfield Freeway. Transportation will be provided from Southwestern High School to

the Doubletree for those who need it.

Public Comments

Richard Rosen: Asked the year the Mackinaw Straits Bridge opened. Hugh McNichol

responded: November, 1957. Mr. Rosen then read from a June 12th letter to the editor of the

Detroit Free Press. It indicated that the Commission was established in 1950. His point was that

the P3 process was not faster than normal processes. He went on to read that some economist

said that they believed that private interest (P3) in the infrastructure would cost more.

<u>Richard Rosen:</u> Asked when the formal DRIC study process began and when bridge construction is expected to be completed?

Mohammed Alghurabi responded that the study began in 2000 and it will take approximately 7 years from the date of the signing of the P3 legislation to complete the construction of the bridge.

<u>Richard Rosen:</u> Commented the cost of cement and steel would affect the aesthetics of the bridge.

Mohammed Alghurabi responded the aesthetics of the bridge do not depend on cost only. Performance specifications will be developed and context sensitive solutions will play a key role in the final design of the DRIC bridge.

<u>Jesse Gonzales:</u> Commented there are rumors about what people are going to get for their homes and it is troubling people in the community. Also, Detroit has been on CNN and the local news as having the worst air pollution and wondered if this bridge would add to the pollution.

Mohammed Alghurabi stated the acquisition and relocation process will be fair. He also noted that the non-profit organization known as "Bridging Communities" is working with MSHDA and the community to build new homes for residents to be relocated who do not want to leave Delray.

Mohammed Alghurabi indicated that DRIC studies suggest that the air pollution will not get worse with a new bridge.

<u>Jesse Gonzales:</u> Commented that the State of California instituted a truck idling law and is adding emission filters to trucks. He asked: "Can they be used here?"

Mohammed responded that strategies to mitigate air emissions will continue to evolve, including the EPA requirements for the introduction of new diesel engines.

<u>Delores Leonard:</u> Asked what are the Senate and House bill numbers for the P3 legislation.

Mohammed Alghurabi said they were HB 4961 for the P3 legislation and & HB 6128 for the

community benefits bill.

<u>Delores Leonard:</u> Asked if HB 6128 has to go to the Senate?

Mohammed Alghurabi said it did.

John Bendzick: Noted that some legislators believe that there is too much authority given to

MDOT in the P3 legislation. This is the position of Representative Opsommer.

Notes of LAC/LAG May 25th

Mohammed Alghurabi asked if there were any changes needed to the notes of the last LAC/LAG

meeting. Frank Rodriguez noted that on Page 4 in the 5th paragraph that he asked the question on

Welcome Center hours.

Deacon Norbert Motowski stated that he was listed as a "Father". He's not a priest but a Deacon.

SWCBC Update

Simone Sagovac provided the LAC with an update of Community Benefits Coalition issues. She

noted that HB 6128 has been assigned to the Senate Government Operations committee where it

is likely to die. In turn, Senator Buzz Thomas introduced SB 1395 on community Benefits. It has

been assigned to the Transportation Committee where it has a better chance of being acted on.

Simone indicated members of the Coalition have testified to the legislature. Positive feedback

has been received. She also noted that Senator Hansen Clarke is trying to ensure community

investment process goes forward. Simone urged all in attendance to contact Senator Bishop to

urge him advance the community benefits bill.

Meeting the DRIC Reporting Requirements

A question was asked how the June 1st legislative deadline for approving or disapproving the DRIC was missed? Mohammed Alghurabi responded the June 1st deadline was not binding. Currently, MDOT is working with the Senate to answer additional questions.

DBE Certification/Pre-Qualification

Terrance Hicks, MDOT's Director of Business Development, provided a detailed explanation of the Disadvantaged Business Enterprise certification process noting MDOT examines such characteristics such as experience, financial condition and number of employees in the company. The DBE certification process is challenging.

MDOT also has the Road Construction Apprentice Readiness (RCAR) Program which involves 9 weeks of intensive training to prepare individuals for apprenticeships and jobs with construction contractors. Terrance Hicks advised that ACCESS is conducting the training for Detroit and will be held at places like ACCESS.* Additionally, there are workforce diversity forums to encourage businesses and individuals to be involved in government-sponsored construction projects. Some of these have been sponsored by Detroit Council member Spivey and State Representative Bert Johnson. Once the DRIC bridge is built, there will be long-term jobs that become available. Efforts will be made to help equip those interested in these jobs, with the required skills, as they become available.

<u>Commissioner Ilona Varga:</u> Asked if the state would recognize Wayne County's DBE's Terrance Hicks indicated those that have met requirements that MDOT applies will be recognized.

<u>Commissioner Ilona Varga:</u> Commented that job training should be held locally and that Tom Cervenak has offered the Delray Neighborhood House for this purpose.

<u>Harold Day:</u> Asked if MDOT is working with skilled trade unions like Locals 394 and 1197. Mohammed Alghurabi said yes.

Real Estate Video Presentation – "Public Roads & Private Property"

Audio equipment was not arranged by The Corradino Group so the video was not shown.

Other LAC/LAG Business

Mohammed Alghurabi reading from an update on the Gateway Project provided by Victor

Judnic noted: 1) new ramps to SB I-75 are open; 2) the carpool lot is almost finished; 3) the

Michigan Supreme Court refused to hear the DIBC lawsuit appeal and, subsequently, DIBC filed

a motion in Federal District Court; and, another federal court has ruled DIBC is not an

instrumentality of federal government.

Additional Public Comments

Harold Day: Asked if reconstruction of Fort Street and affected bridges has been coordinated

with the Detroit Police, Fire and EMS departments.

Mohammed Alghurabi responded that he believes such coordination is underway.

<u>Jesse Gonzales</u>: Asked for more information on the housing acquisition process.

Susan Fredericks responded that once MDOT is given the go ahead on a project, the first task is

to order the title work on individual properties which can take several months to complete.

MDOT arranges for appropriate appraisal work. Making an offer to purchase can be a lengthy

process.

Jesse Gonzales: Asked what standards will be used for the appraisal?

Gerry Lacey said the property is appraised at fair value. To that amount 25% is added per state

law. The final amount of compensation MDOT offers must replace allow the owner to move into

a "Decent, Safe and Sanitary" replacement house which, in some cases can be more than the fair

value of the existing house plus 25%.

<u>Ilona Varga:</u> Suggested a one-page document explaining the acquisition process would be very helpful.

<u>Richard Rosen:</u> Asked if a person lives in a home located in an industrial area, will MDOT relocate that person to another area like that where the pollution is bad and the environment is awful? Mohammed Alghurabi said no.

Mohammed Alghurabi stated that MDOT is not pursuing any acquisitions at this time. When MDOT personnel begin the process they will have proper identification. If anyone has any concerns they can call people from the community such as John Nagy, Debra Williams, and him for more information.

Next LAC/LAG Meeting

Mohammed Alghurabi asked that persons requiring transportation to the Doubletree Hotel for the LAC/LAG meeting on July 28th, to please submit their names so arrangements can be made. With that, the meeting ended at about 8:30 p.m.
